MH17- THE US WILL NOT PROVIDE THE NETHERLANDS WITH SATELLITE IMAGES

The [US informed the Netherlands that they cannot provide declassified satellite images which allegedly show the launch of a BUK missile responsible of the MH17 crash](https://ria.ru/20200608/1572620877.html)

(<https://ria.ru/20200608/1572620877.html>) in the Donbass six years ago. The presiding judge, Hendrik Steenhuis, said this at a meeting on the passenger plane crash case.

The MH17 crash hearing resumed on Monday 8 June 2020. Few months ago, the MH17 court asked the US to provide declassified satellite images which are mentionned as a source in a report that they sent back in 2014, as a proof of a BUK launch.

“The Court asked whether classified satellite images of the missile launch, which had been handed over to Dutch intelligence services, could be added to the case and thus declassified. The prosecutor’s office replied that the request was sent to the United States back in 2014 and a memorandum was received in response. The Dutch National Antiterrorist Prosecutor was able to verify that the memorandum was correct,” the judge said.

“The prosecutor concluded that the memorandum was supported by other sources that he consulted. He also requested that his findings be attached to the file. The United States authorities informed that they are unable to provide additional data regarding the launch of the missile to supplement the memorandum. Thus, additional information on the launch of the missile was not attached to the file,” concluded the presiding judge.

According to Steenhuis, this way, the prosecutor was able to review classified documents in confidence. But in reality, as it was discovered during an interview of Fred Westerbeke, the Dutch did not have access to the US satellite images, but to a report supposedly based on these images (<https://www.donbass-insider.com/fr/2020/03/12/mh17-le-proces-de-la-honte-a-commence-aux-pays-bas/>)! It means the US could write whatever they want in this report, without the images to prove what the report claims, it is not a proof at all. Would you believe a report saying that the aliens destroyed the MH17 without any serious proof like satellite image? Of course not. Then why accept it when it claims they saw a BUK launch?

The Russian Federation has repeatedly demanded to provide data from the Ukrainian radars (primary radar data) and US satellites as part of the investigation of the MH17 crash. But these data were never provided. Why do the US not show the satellite images, and why Ukraine pretends that all its civilian primary radars in the area were not working?

Bonanza Media journalists, have found some witnesses interviewed by the JIT, or Dutch journalists, who say that they saw Ukrainian fighter jets circling in the sky just before the MH17 crash.

The same fighter jets, that Ukraine claims were not in the Donbass sky this day. Fighter jets which would appear clearly on satellite images, or Ukrainian primary radars (they could be absent of Russian primary radar, because of the distance to the radar, and the curve of the Earth, if they were flying below the radar detection threshold). There is no valid reason for the US not to provide these images. Nothing prevented the US to publish satellite images of Russian airplanes in Syria in 2015 (<https://abcnews.go.com/Politics/russia-now-28-fighter-aircraft-syria-us-officials/story?id=33930851>). So why is it a problem to publish US satellite images concerning the MH17 crash? Perhaps because they show something which is not fitting the official narrative.
